#### 4. INSURANCE REQUIREMENTS

\_\_\_\_\_ If my personal policy does NOT provide full coverage, I must purchase **MBA Commercial RV Rental Insurance** at my own expense.

\_\_\_\_\_ MBA insurance carries a **\$1,500–\$2,500 deductible** depending on RV unit.

\_\_\_\_\_ If the RV is **delivered, set up, and remains stationary** during the rental, I may elect an **Insurance Waiver + nightly surcharge** instead of MBA.

#### 5. RETURN CONDITION AGREEMENT

##### Initials Statement

\_\_\_\_\_ I understand **if I am not present at return**, Stress Free RVs' final inspection will be **final and legally binding**.
